For 2021, we have you and your needs in mind...

We are working on another Emergency Medicine CME activity. This webinar will be focused on Pediatric Emergency Medicine. It will likely take place during the summertime. Further details will be provided soon. ACEP Puerto Rico has been working to improve our specialty recognition in the Island. As trained Emergency Medicine physicians, patient stabilization is intrinsic to our specialty. We excel at managing the unstable patients.

Our training and continuous education standards go beyond the short courses required to work in Puertorrican hospitals such as: ACLS, PALS, BLS etc. Therefore, we submitted a resolution in the recent "Colegio de Médicos de Puerto Rico" senate meeting. The resolution was titled: "Derrogación de Cursos Cortos". This resolution asked the "Colegio de Médicos de Puerto Rico" active involvement in the elimination of the requirements of ACLS, BLS, PALS, ATLS for board certified Emergency Medicine physicians.

During this meeting, another resolution was presented. It was title "Creación de Comité Asesor Departamento de Salud-Reglamento de Hospitales". Recently the Puerto Rico Health Department released the 2020 hospital regulatory procedures. We were against several key points concerning the Emergency Department. Therefore, the resolution stated that a committee composed from all specialties affected by these regulations needs to be created. This committee will be placed at

the disposition of the Puerto Rico Health Department for the development of future regulatory procedures.

Senate Meeting & EM in Puerto Rico Fernando L. Soto-Torres, MD, FACEP - President Elect

Last year the Emergency Medicine Chapter was reactivated at the College of Physicians and Surgeons of Puerto Rico (Colegio de Medicos y Cirujanos). A few of our members participated in the process and ended up becoming part of the chapter at that institution. Some of the members include: Dr. Eddie Rodriguez as President and Dr. Miguel Agrait as Vice President, and myself as representative to the senate; among others.

As part of our responsibilities, we participated in the Senate meeting where discussions take place regarding the work, lives, and well-being of our fellow physicians throughout the island. This is a crucial forum where topics can find a platform from where ideas can be presented, discussed, and moved to become protocols, initiatives and, in some cases, laws or regulations.

The first two resolutions presented by our group- and in representation of PRACEP - involved the so- called "merit badging" required by certain institutions for us to work in the emergency department as well as the recently published "Reglamento 9184 de 1 de julio de 2020" also known as "Reglamento del Secretario de Salud para la Construcción, Operación7, Mantenimiento y Licenciamiento de los Hospitales de Puerto Rico".

In the first resolution (see here) we argued that the request to remain certified in ACLS, PALS, and ATLS by several hospitals and our own local licensing board (Junta de Licenciamiento Médico de Puerto Rico) in order to have a license and work is not necessary as per our own guidelines. This resolution was withdrawn for amendments. Our colleagues at the senate believed that - despite our concerns that these courses contribute so little to our knowledge base and are not essential for our practice as board certified emergency physicians, they are still considered requirements by many institutions such as the Joint Commission and CMS. After further review we will resubmit at the next session.

The other resolution submitted was about the "Reglamento 9184 de 1 de julio de 2020" (see here). We recommended the active participation in the creation of these regulations for hospital operations in the Commonwealth of Puerto Rico. As was observed by many of our emergency medicine colleagues, this list of regulations - which went into effect on June 2020 - state, for example, that any general practitioner (GP) with even 1 year experience may act as director of the emergency department. It also states that all those who work in the ED must possess BLS, ACLS, etc; and furthermore, implement other guides on how to run our emergency departments and hospitals that affect us directly.

Through this resolution we requested that all hospital-based specialties have a say in the development of the regulations that will define the operation of hospitals in the island and the lives and working conditions for physicians. It was approved.

Starting next month, a committee will convene, and I will oversee the process. I will take all your requests and take them through the appropriate channels and, hopefully, institute change.

This is some of the work we have been doing but there is much to do. We will go as far as those who participate will take us. Keep active and interested. And keep in touch. If you have any suggestions or have any ideas that you believe can be addressed at the level of the 'Colegio de Medicos' or any other forum, please let us know.

At the Puerto Rico Chapter of ACEP we are always concerned about what our colleagues are going through and thinking about ways to improve the lives of our physicians and the care of our patients. We believe that the best emergency care is provided by a board-certified emergency physician and we will continue to work so that every emergency is addressed by a specialized professional.

Breaking Down President Biden's Executive Order on Strengthening Medicaid and the Affordable Care Act

Since taking office, President Biden has issued a plethora of executive orders, mostly related to tackling the COVID-19 pandemic and reversing or adjusting policies implemented by the last administration. As a reminder, executive orders themselves do not effectuate new policies. Rather, in most cases, they call on federal agencies to examine or institute new policies—usually through regulations. On January 28, President Biden issued a broad sweeping Executive Order on "Strengthening Medicaid and the Affordable Care Act." READ MORE
